### SIMONE RIZZUTO

- Simone shared her yearly reflections for 2023, by each Term, highlighting key activities completed, achievements and everything to be proud of as a school.
- Key areas highlighted included:
  - Recent PAT data and Check-in Data has shown that programs of learning practices are showing positive progress in student results and school will build on these for 2024.
  - Tell them from me Survey completed with parents submitting request yearly and students twice yearly. Key results for discussion included how parents/carers/students 1) Felt welcomed to school 2) School listened to parents 3) Informing of Behaviours 4) Opportunities for Students needing development and 4) Recommendation to WHPS. Whilst results were slightly disappointing, information allows the school to work with parents in 2024 to solve challenges together.
  - Sport Got Game introduced in 2023 and will be re-run in 2024. Had great success in PSSA and will occur in 2024 but still unsure of format.
  - Performing Arts school presented many great opportunities which resulted in wonderful achievements and showcasing the community.

- Sustainability thank you to the P&C for completing the Chicken Coup for the School. Has not only added to the appeal of school but has supported students with wellbeing. Thank you also to Elizabeth our volunteer Horticulturist. Confirmed we have received a grant to plant 200 new plants on the school grounds of which the Year 5 students will be involved in.
- Aboriginal Education continued to grow on the work in this area completed in previous years. Our staff show great passion and commitment to this area. Some of the activities across the year which highlight this includes: NAIDOC Week, Acknowledgement of Country Book, National Reconciliation Week and Sorry Day, Staff development days had a focus on Aboriginal Education, Staff attendance at after school AECG Meetings (WHPS being more represented school).
